The Curriculum Committee met Wednesday, February 10, at 3 p.m. in LIB 103.

Proposals from Don Derkacht to:		
1. revise course:	CS 249, Advanced Operating Systems	5 cr, 33 lec, 44 lab
Discussion:		
Remove prerequisite of CS 111 (not a meaningful prerequisite for CS 249), add CS 144, Principles of PC Operating Systems. Prerequisite of CS 170 will remain since CS 249 requires knowledge acquired from CS 170 to enable success. Course outcomes and assessment methods have been modified to reflect current language and practice.

Effective Winter 2011.

2. revise course:	CS 281, Digital Design	6 cr, 33 lec, 66 lab
Discussion: Increasing the number of credits from 5 to 6 and lab hours from 44 to 66 to allow time to introduce students to elementary circuit theory before moving onto the study of digital design. CS 281 is offered to students seeking a BS in computer science and is especially important for students transferring to WSU-V. CS 281 is not a requirement for our degree or certificate programs. A lab fee may be applied to this course at a later date. This course is typically taught once a year - summer 2010. Course outcomes and assessment methods have been modified to reflect current language and practice.

Effective Summer 2010.

Proposal from Charlotte Persons to:		
3. suspend course:	ENGL 069, Second Language Grammar & Writing	1-5 cr, 22-110 lab
Discussion: This course was created to help ENL students with below college level abilities in speaking, listening, reading, and writing English. ENL courses are no longer offered and students currently taking this course do not fit the profile of the students for whom the course was designed. The course and materials are out of date. A better option for student is to take the 2 credit ENGL 072, 073, or 104.

Effective Spring 2010.

Proposal from Kathy Demarest to:		
4. add course:	COLL 095, Time Management	1 cr, 11 lec
Discussion: This new course will focus on all the issues of time management: scheduling, study environment, procrastination, setting realistic goals, using outside resources, etc. - items which had been covered during orientation workshops. Students have asked for more assistance managing their schedules with work and family obligations. Students will be able to evaluate their study environment, determine best time of day for study, achieve longer term academic goals and Support Services can be enlisted for additional help. The course will be completely online and Kathy will be contacting students every week. This course does not duplicate any Self-paced Learning course but may be offered as SPL in the future. FTE's will be generated due to course's continuous enrollment. The committee suggested several amendments: change hours (22) from Lab to (11) Lecture, strike repetitive language in course description, mark as "restricted" rather than "elective", and update the course outcomes with more definitive wording.
